AS A NATIONAL OFFICE, AWARD USA RECEIVES PAYSCALES WHICH INCLUDE CEO AND SENIOR MANAGEMENT POSITIONS WEIGHTED FOR COST OF LIVING TO THE US FROM THE DUKE OF EDINBURGH'S INTERNATIONAL AWARD FOUNDATION. THESE PAYSCALES WERE BUILT GLOBALLY WITH A LARGE CONSULTANCY FIRM AND REFINED IN CONSULTATION WITH LOCAL US EXPERTS AND RECRUITMENT SPECIALISTS IN NON PROFIT MANAGEMENT. THEY ARE UPDATED ANNUALLY.
